**More from Annette:** The Board is not voting to change isolation or quarantine policies at its meeting on Jan. 12. The Board is continuing a November 2021 rules hearing on the proposed rule changes to chapter 246-100 WAC, Communicable and Certain Other Diseases, as published in WSR 21-20-127 at the meeting. The Board is proposing updating its rules to reflect current state law to align with Engrossed Substitute House Bill (ESHB) 1551. Agenda item 9, while related to rulemaking on chapter 246-100 WAC, is scoped only to the implementation of ESHB 1551 (Chapter 76, Laws of 2020) and does not include changes to isolation and quarantine policies nor does it suggest law enforcement be used to enforce any vaccination requirements. **JUST IN from Rose M., Clallam County:**

“I got a response from Sheriff Bill Benedict via a phone message about the forced quarantining of people and families, on my phone. He said....’Do not worry. That is misinformation. The Sheriff and Police Chief Organization has said we do not support it. If it was passed into Law we would not enforce it.” ~Marvelous Monday, Rose M.

**Rose also wrote this:** I emailed the state BOH (doubt I’ll hear back) to inform them that the registration questionnaire they are requiring the public to fill out is in violation with the Washington State Open Public Meetings Act, see below.

RCW 42.30.040

*Conditions to attendance not to be required.*

*A member of the public shall not be required, as a condition to attendance at a meeting of a governing body, to register his or her name and other information, to complete a questionnaire, or otherwise to fulfill any condition precedent to his or her attendance.*

Granted, Inslee has suspended portions of the OPMA already (specifically, requiring IN PERSON attendance to governing body meetings, ie commissioners meetings). So it may be that this is a portion that is also suspended.

But still...

The suspension of the OPMA should concern EVERYONE, it is literally what gives the public the authority and power to hold their elected officials in check.

From the opening statement:

*“The people of this state do not yield their sovereignty to the agencies which serve them. The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people insist on remaining informed so that they may retain control over the instruments they have created.”*

THIS document is what has been suspended by our governor, which is why we cannot attend our board of commissioners meetings in person, this is how they’re able to required to us register and fill out questionnaires in order to GIVE public comment. And I’m sure how you answer that questionnaire will have \*no\* impact on your ability to give public comment right? I’m sure it won’t be put into some sort of a database linking your full name with your opinion and view of government activities (a la school board meetings vs DOD anyone?) right?
